

# EXECUTIVE COMMITTEE MEETING AGENDA

Dean Olevsky called the meeting to order at 2:01pm.

#### 1. URAD Engineering Update

Kate Carinder, Senior Director of Development for Engineering, provided the following updates:

i) Roger Ball, President, Rick Engineering, Co., has been chosen as the College of Engineering Distinguished Alumni; ii) Joe Kiani (ECE Alumnus) Founder, Chairman & CEO, Masimo Corporation, has accepted and will be conferred with an honorary Doctor of Science (Sc.D) degree at the 2020 College of Engineering Commencement Ceremony; iii) Teresa Kruckenberg, Ph.D., Director, R&T – Aerostructures, Collins Aerospace, has accepted to serve on the Engineering Dean's Advisory Board; iv) Kate is reaching out and thanking people for their giving; v) SDSU Rocket Project was given Siemens simulation software licenses valued at \$1.5M; and vi) Robert Woodcock is giving an additional \$100K to SDSU Rocket Project.

Dean Garoma presented a slide with a total of 90 JDP applications (35 complete & 55 incomplete) received as of 3/13/2020; ii) SDSU JDP Steering Committee met on 3/13/2020 to discuss admission recommendations; and iii) Dean Olevsky inquired about the process for student qualifying exams as the exam usually takes place in-person at UCSD. Interim Assoc. Dean Garoma provided an update that clarification will be coming in the next week from Ed Balsdon and UCSD.

#### 11. <u>UG Curriculum Issues</u>

Interim Assoc. Dean Ozturk commented that all Engineering professors are doing a phenomenal job in converting their courses online. There are concerns with online exams and some faculty are planning to use REspondus and Respondus Monitor to alleviate cheating for online exams, but may cause students additional stress.

# 12. GI 2025 Update

Asst. Dean Garcia provided the following updates:

1) In regards to COVID-19: i) Asst. Dean Garcia is working with Interim Assoc. Dean Ozturk, CSSE, MESA and Bianca Portal, Internship Coordinator, in moving CoE peer tutoring and advising to a virtual mode beginning on Monday; ii) Currently there are messages on the CSSE website for students that have special concerns; and iii) the Executive Committee Members approved for Asst. Dean Garcia to

include in an e-mail to students that the students will still have access to their faculty for questions related to their course content advising and office hours.

Asst. Dean Garcia provided an update that DEI deadlines have not yet changed, but work has been suspended due to COVID-19.

Dean Garoma presented a slide with the 2021 U.S. News Best Graduate Schools Rankings released last week: SDSU Engineering – tied 133; Aerospace – tied 53; Bioengineering – tied 107; Civil Engineering – tied 75; Computer Engineering – tied 106 (discussion was brought up that the CoE does not have a Graduate Program in Computer Engineering); Electrical Engineering – tied 106; and Mechanical Engineering – tied 94.
